

# ANNUAL PARKING ENFORCEMENT REPORT for the period 2023/24

### 1. INTRODUCTION

1.1 The information contained in this report is in accordance with section 55 of the Road Traffic Act 1984 as amended by Traffic Management Act 2004.

#### 2. BACKGROUND

- 2.1 The District Council operates over 50 car parks with over 6000 spaces. These are managed under the regulations set out in the 'District of New Forest (Off Street Parking Places) Order 2005'. A copy of the Order, car park locations and charges can be found on the Council's web site (www.newforest.gov.uk/parking).
- 2.2 The District covers an area of approximately 290 square miles with a resident population of 173,000. We now have an estimated 15 million visitors annually and a high percentage of these visitors will make use of the councils pay and display car parks during their visits. Hampshire County Council is responsible for the enforcement of on-street Traffic Regulation Orders. This includes enforcement of single and double yellow lines, limited waiting bays, loading bays, motor-cycle bays, taxi ranks, bus stop clearways, pedestrian crossings and onstreet disabled bays.

## 4. CONCLUSION

- 4.1 The number of PCNs issued in 2023/24 was higher than the previous year. The current PCN levels continue to reflect well on the current high compliance rates in our car. This has been achieved through maintaining early and late cover in addition to daytime patrolling during the summer months and it this targeted patrolling that leads to improved compliance and therefore greater overall ticket sales income.
- 4.2 With the adjustment to the split of employee costs to other services the enforcement team provide, plus improved income from dispensations (contractors paying for temporary compound licences in our car parks to facilitate local works), the overall enforcement account deficit is similar to the previous year with a slight decrease where dispensation and PCN income has offset the employee costs, caused by the increased wage bill reflecting pay rises.
- 4.3 19% of all PCN's received were cancelled following either informal challenges or formal representations. The percentage cancelled at formal representation remained at 1% of all tickets issued which highlights that most challenges are dealt with during the informal challenge stage. The number cancelled at informal challenge stage increased, primarily due to a significant reduction in warnings for parking clock misuse.
- 4.4 All motorists receiving a PCN can now see their case details and photos taken by the Enforcement Officers at the start of any online payment or challenge and this it is anticipated will, in time lead, to a reduction in challenges overall which will be reflected in next years figures.
