We feel strongly that neither our Infant school, nor our Junior school should be used as Polling Stations for the following reasons:  1. Safeguarding of children. We understand that it is discretionary for senior leaders to close the schools when part of the building is being used as a Polling Station; however, we feel due to safeguarding of the children within our care we cannot remain open while members of the public walk in and out of the building freely. We know from past experience that members of the community and members of the Polling Staff do not respect the requests from the school to keep within marked areas and to respect the rules of on site visitors to the school (no animals on site as an example). After many bad experiences of being a Polling Station, the last time we were used, I ended up having to write a serious letter of complaint to NFDC, the outcome of which was an apology from NFDC for the behaviour of their staff and an alternative venue was found and used for subsequent elections. However, due to the recent boundary changes the alternative venue found is no longer viable, but we remain scarred by the experiences and strongly believe alternatives are available.  2. Closing a school each time a public vote is required is harmful to children's education. After two years of pandemic and disrupted education, there is now again, a lot of emphasise on attendance and monitoring of attendance by the DfE and Ofsted. There are panels and early help hubs for families with attendance issues, penalties issued by County when a child is not attending school. In the 'Hampshire County Council Good School Attendance Guide'	We would like to propose 2 alternatives to using Wildground Federation as a Polling Station for polling district HN.  1. The HN polling district for Hythe South ward could vote at HO's Polling Station which is St Anne's Neighbourhood Centre, Warrys Close, SO45 3QR. St Annes Neighbourhood Centre is a community hall in the heart of the Netley View Estate. If you visit https://www.hants.gov.uk/educationandlearning/findaschool/schooldetails?dfesn o=2057, you will see that the boundaries for Wildground Federation catchment area has the same boundaries as HN ward and HO ward put together. If Residents that live in HN or HO wards are expected to attend Wildground Federation as their catchment school, then Wildground Federation can reasonably expect residents that live in HN and HO to vote at St Annes Neighbourhood Centre, which is more centrally aligned in the area than the Federation is! The already established Polling Station has a hall large enough for 2 wards. Both HN and HO are in the same district so the voting papers would not be an issue. There are Polling Stations in Hythe that host 4 wards, so it is reasonable to ask for St Annes Neighbourhood Centre to host both HN and HO wards.  2. A second alternative Polling Station would be to use the facilities at The Glen, SO45 3RF. This venue has a separate Function Room, it has public conveniences and kitchen facilities. It is a well known venue in the HN ward area. There is a separate entrance to the function room, so the main venue would not necessarily need to be used for those residents that would not wish to enter the public house part. There is plenty of parking onsite and there is disabled access. This venue is as close to the boundary of the ward as Wildground Federation is, so it should be acceptable from a distance to travel perspective.

3. The month of May is a favoured month for elections. It is also one of the most important months for a school. In an
Infant school there are Year 1 Phonics tests in May, there are KS1 SATS tests that effect Year 2 also in May. Within the
Junior school there are Year 4 Mathematics Assessments and also KS2 SATS tests that effect Year 6. Four year groups are
sitting examinations in the month of May. This is a stressful month not only for staff but for the children as well. These
children are being tested and assessed from the age of 5 to the age of 11. To close a school for elections in this month in
particular, is irresponsibly unfair on all involved.

- 4. The 3 reasons above can be applied in general to any school being asked to be a Polling Station. There are only three schools mentioned as Polling Station venues within the whole of the New District Ward map for the New Forest area, one of them has a separate community room which means they are not affected in the same way as Wildground Federation and Waterside Primary. Wildground Federation is not only an Infant and Junior school, but we also have a Nursery setting on site which is funded by government grants and by parents. If we have to close the Infant school then parents whose children are booked in for Nursery sessions on that day will not only lose their session fee, but they will also have to arrange childcare for the children that are supposed to be at Nursery which could mean more fees, or the use of an annual leave day/unpaid leave from work, both of which are unfair for the parent. Wildground Federation serves one of the most deprived areas in New Forest West; so the financial impact on the parents of the Nursery must be considered. If we are to be a Polling Station, will we have the fees lost/incurred reimbursed for the families affected?
- 5. Wildground Federation has 3 Resource Provisions. An Early Learning Group (ELG) which is a joint funded Education and NHS provision for children with speech, language and communication needs; a Social, Emotional, Mental Health (SEMH) provision and an Autistic (ASC) provision. The children attending these provisions are vulnerable children that have different needs to main stream children. Closing the setting for these children has greater impact than closing main stream classrooms. Wildground Federation also has a higher than average SEN% (Special Education Needs) rate. The average SEN% across New Forest West Primary Phase schools is 16%, at the end July 2022 our Infant school SEN% was 36% and our Junior school was 40%. We are an inclusive school with a very complex cohort. By closing our school in order to use a room as a Polling Station has an impact on a higher number of children with SEN than other schools.
- 6. I have met with NFDC representatives during this consultation phase and have been advised that the selecting of Wildground Infant school as a Polling Station is just "geography and not personal". That may be the case, but there are 55 Primary phase schools in New Forest West area and only 3 of them are listed as Polling Stations on the Returning Officers Report. In April 2022 on the Hampshire SEN Census data Wildground Junior school had the highest EHCP + SEN % out of all the Primary Phase schools in the whole of Hampshire, the Infant school was #44; but since April the Infant school have had an extra 7 ECHP's, which would make the Infant School #5 in the whole of Hampshire. Wildground Federation schools are the ONLY Primary Phase schools from New Forest West area in the Top 10 most complex schools in Hampshire, meaning our children have the highest level of need in New Forest West area. By making Wildground Federation (in particular) close, while 53 other primary phase schools in New Forest West are able to continue to deliver education to their children, an act of "Structural Discrimination" has occurred. Our extremely high level of SEN and EHCP pupils, from a most deprived area of New Forest West, that are being treated differently to those in the rest of the New Forest District Ward, bring us within the definition of unintentional structural discrimination. To rectify this unintentional structural discrimination we have recommended 2 strong and viable alternative Polling Station venues.
