

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The New Forest (Reorganisation of Community Governance) (Godshill, Breamore and Fordingbridge) Order 2010

Made: 16 December 2010

Coming into force in accordance with article 1(2)

New Forest District Council ("the council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 13 December 2010:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by sections 86, 98(3) and 240(10) of the 2007 Act.

Citation and commencement

1. (1) This Order may be cited as the New Forest (Reorganisation of Community Governance) (Godshill, Breamore and Fordingbridge) Order 2010.
- (2) It shall come into force on 1st April 2011.

Interpretation

2. In this Order –

"district" means the district of New Forest

"map" means the map marked "Map referred to in the New Forest (Reorganisation of Community Governance) Order 2010" and deposited in accordance with section 96(4) of the 2007 Act

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Alterations of parish areas

- 4.-(1) The area coloured and designated by the letter "A" on the map shall cease to be part of the parish of Fordingbridge and shall become part of the parish of Godshill
- (2) The area coloured and designated by the letter "B" shall cease to be part of the parish of Godshill and shall become part of the parish of Breamore.

Electoral register

5. The registration officer for the New Forest District shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Order date

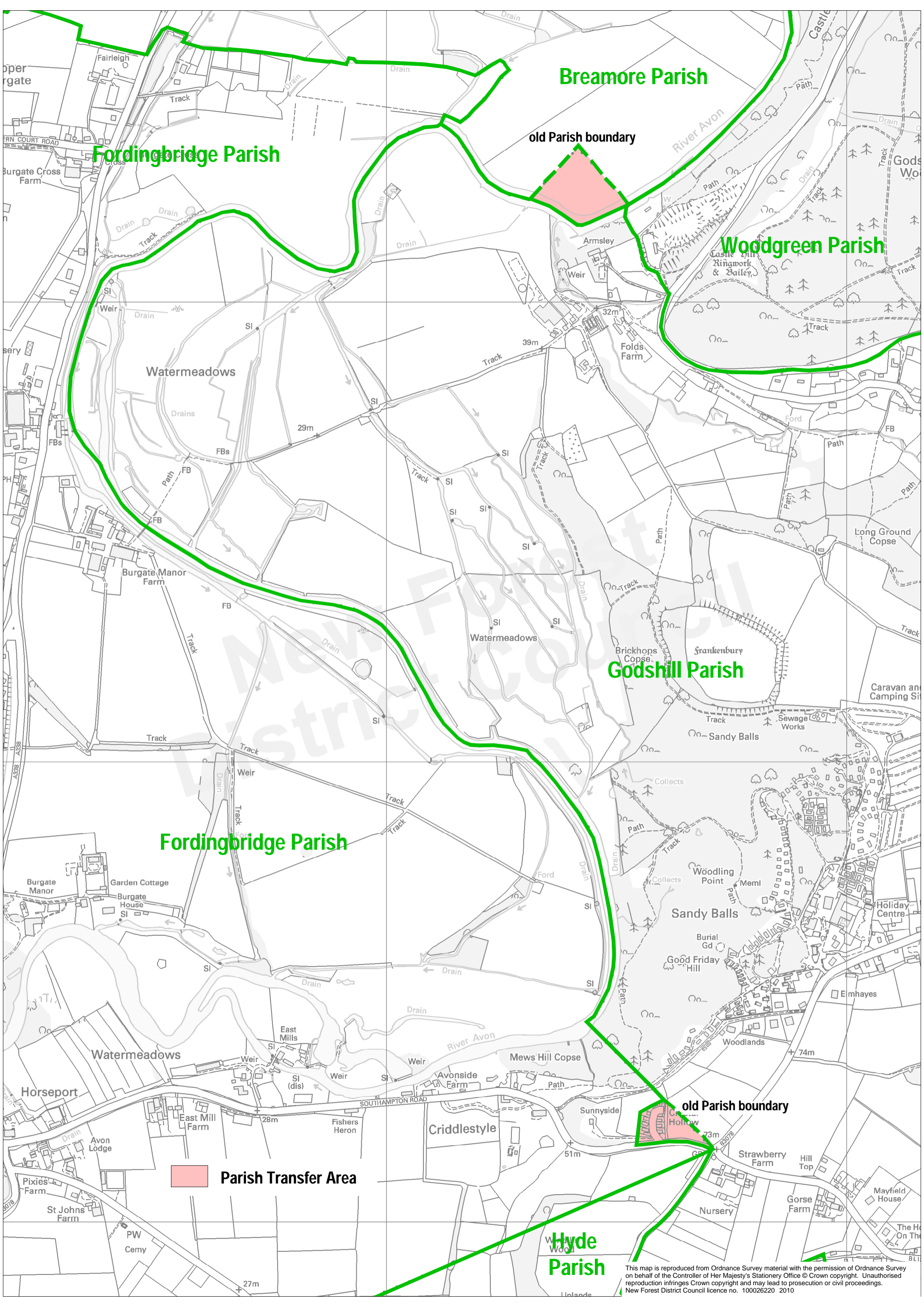
6. 1st April 2011 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008
