We note the proposed amendments to the scheme that have been drawn to residents' attention in a letter from Chapman Lily Planning Limited, in a letter with the reference GM-3131.

We have previously made collective representation on the appeal via the Planning Inspectorate portal. Given that our representation focussed principally on reasons for refusal numbers 1, 2, & 7 per the New Forest District Council Decision Notice of 19 December 2022, the amendments proposed to the scheme have no bearing on our representation, and our previous comments stand.
